



TPF INDEMNITY AGREEMENT

I, the undersigned, agree to indemnify and save harmless TPF Association, Inc. - D.B.A. TPF Forwarding Network; D.B.A. TPF Network (Indemnities) and its successors and assigns from any expense, including attorney fees and costs, cargo damage claims, deductible payment, claim, action, liability, loss, damage or suit arising from the use of the TPF Bill of Lading and/or the use of the TPF Bill of Lading insurance policy.

I, the undersigned, agree to indemnify and save harmless TPF Association, Inc. - D.B.A. TPF Forwarding Network; D.B.A. TPF Network (Indemnities) and its successors and assigns from any claim, action, violation, charges, fines, penalties, loss, damage or suit arising from the use of the TPF Association Inc. tariff filed with the United States, Federal Maritime Commission and/or the NVOCC bond.

In the event of any asserted claim, the Indemnities shall provide the undersigned reasonable timely written notice of same, and thereafter the undersigned shall, at its own expense, defend, protect and save harmless Indemnities against said claim or any loss or liability thereunder.

In the further event the undersigned shall fail to so defend and/or indemnify and save harmless, then in such instance the Indemnities shall have full rights to defend, pay or settle said claim on their own behalf without notice to the undersigned and with full rights to recourse against the undersigned for all fees, costs, expenses including attorneys fees and cots, and payments made or agreed to be paid to discharge said claim.

The person signing this Indemnity Agreement hereby represents that he she is authorized by his/her company to do so.

Upon default, the undersigned further agrees to pay all actual attorneys' fees necessary to enforce this agreement.

This agreement shall be unlimited as to amount or duration.

This agreement shall be binding upon and inure to the benefit of the parties, their successors, assigns and personal representatives.

The obligations and responsibilities of the Indemnity Agreement survive termination of membership.
